

**AGREEMENT
ON ACADEMIC COOPERATION**

between

**AAB UNIVERSITY
Prishtina**

and

UNIVERSITY OF SARAJEVO

In recognition of the importance of exchanges in the domains of teaching and research, as well as the special opportunities provided by strengthening contacts between faculty members and students at the two institutions, **AAB University** and the **University of Sarajevo** are signing the following agreement in the field of academic cooperation.

Article 1.

The goal of this agreement is to encourage exchanges between the **AAB University** and the **University of Sarajevo**, in all academic fields represented at both Universities.

Article 2.

The cooperation between the two respective institutions should specifically promote the following activities:

- Mutual exchange and collaboration of professors, researchers, students, artists and other staff at both the undergraduate and post-graduate levels;
- Organization of summer universities, seminars, symposiums scientific meetings, different forms of artistic activities (concerts, exhibitions, film, multimedia) and other forms of exchange of knowledge by both parties;
- Exchange of literature, textbooks and university publications;
- Realization of mutual research and artistic projects;
- Exchange of experiences and mutual programs in the field of information systems and communications;
- Exchange of administrative staff with the goal of gaining the necessary experiences and changes;
- Cooperation in the field of the university reform in accordance to Bologna Declaration and Lisbon Declaration
- And other forms of cooperation aimed to be mutually beneficial for both participants.

Article 3.

All activities mentioned in the Article 2. will base on reciprocity.

Article 4.

Both Universities will at least once a year agree upon the concrete forms and fields of cooperation. These collaborative programs can be changed or amendment by written agreement signed by both parties.

Annex of this Agreement will be made for each specific project and it will define a coordinator of the project for each University , participant in the project, detailed description an working plan of the project with timetable of realisation all defined activities as well as detailed financial plan of concrete project.

Article 5.

Collaborative activities will be reviewed every year.

Article 6.

The present agreement will be signed as an ongoing agreement with no set time frame.

Article 7.

The agreement shall enter into force on the date of the signature by both parties.

Article 8.

Each University has the right to propose annexes and changes of the document in written form and they will begin when they adopted by both sides.

Article 9.


Each University has the right to terminate the present document in writing by providing the other one with written notice in advance at least six month prior to the intended termination. The agreement cannot terminate before the actual annual program is not completed.


Article 10.

Activities which are not included in this Agreement will be agreed by both parties, which shall keep continuing a communication, good will, flexibility and adaptable quality in realisation of this Agreement.

Article 11.

This agreement will be presented in four identical copies (two in each language: English and Bosnian). Each University will receive two copies (one copy in each language).
