## MEMORANDUM OF AGREEMENT BETWEEN AIN SHAMS UNIVERSITY CAIRO – EGYPT

and

### UNIVERSITY of SARAJEVO BOSNIA and HERZEGOVINA

#### WHERE AS

Representative of AIN SHAMS UNIVERSITY OF CAIRO, EGYPT(ASU) and UNIVERSITY of "SARAIVO" BOSNIA and HERZEGOVINA

- 1. Are convinced that cooperation is essential in order to strengthen the relationship between people.
- 2. Share interests in similar academic, scientific and professional goals.
- 3. Intend to increase the human and professional relations which contribute to achieving the aims which both pursue.

#### It is therefore agreed

#### **ARTICLE I**

To promote the development of academic, scientific, technical and cultural relations between ASU and UNIVERSITY of SARAJEVO, through but not restricted to academic exchanges, scientific research, professional internships and technical cooperation.

#### ARTICLE II

#### Academic Exchanges

The exchanges scheme will include professors , scientists , staff members , specialists , students and technicians.

II.1 Exchange of professors, scientific and staff members will be for the purpose of exchanging scientific and teaching experience, giving lectures, exchanging views on joint research projects and joint theses supervision participating in conferences, symposia and post-graduate courses.

II.2 Exchange of young staff members or specialists: The aim is to maintain scientific working relationships with the staff members and scientists in both sides. The number of members and duration of stay are to be negotiated.

#### ARTICLE III

- The authority of each side will pay travel expenses to and from the receiving country.
- The hosting side will cover expenses of accommodation, internal transport, medical care and per diem.

#### **ARTICLE IV**

#### Scientific Research

To allow faculty and qualified graduate students from both institutions to visit the other institution or affiliated institutions for the purposes of individual research or to be members of research team.

#### ARTICLE V

#### <u>Technical Cooperation</u>

To allow each institution to have access to open resources of the other ,such as libraries , films , and slide libraries , technical and academic materials depositories , laboratories and studios for the purposes of enriching and developing their own resources .

#### **ARTICLE VI**

#### Professional Internships:

To allow qualified graduate students from each institution to enter as degree or non- degree candidates as governed by the regulations of each institution e.g. joint theses supervision.

#### **ARTICLE VII**

This agreement will become effective immediately upon signing by both parties.

The term of duration will be for two years to be automatically renewed for equal periods unless one of the parties notified in writing to the other of its intent to terminate the agreement at least six months prior to the renewal date.

Agreement for Collaboration
In Research, Education and
Training Programs
Between Cairo University and
The University of Sarajevo

According to the Executive Program of cultural Agreement between the Arab Republic of Egypt, and Republic of Sarajevo. Both parties agree to a direct cooperation between Cairo University and the University of Sarajevo in the fields of research, education, and in training programs of mutual interest, as stated in the following articles:

#### Article 1:-

The cooperation between the undersigned two institutions will take the form of exchange of staff and students as well as in the preparation and implementation of the following activities:

- Joint workshops and training programs .
- Joint research and development projects.
- Joint education programs.

#### Article 2:-

Nothing in this agreement shall be interpreted as to contravene any of the commitments entered into between each organization and its funding or other institutions.

#### Article 3:-

This agreement may be altered by mutual written consent of both parties at the request of either Cairo University, or the University of Sarajevo. Any alterations shall become effective at the same time that both parties indicate their consent.

#### **Article 4:-**

The present agreement shall be effective for a period of three years from the date it is signed by both parties. It may be renewed for the same period unless written notice is given six months before the termination by one of the two parties

#### Article 5:-

Both universities agree to:

- A-The sending party will be responsible for travel expenses.
- B- The receiving party will be responsible for accommodation.

#### Article 6:-

Both universities will act as a" privilege partner" in all rescarch proposals submitted by one of them.

#### Article 7:-

The two institutions have to nominate a coordinator (s) who will prepare and supervise the executive program .He has to present an annual report about the activities of the agreement.

Two official copies of this agreement in Arabic and English languages, are to be signed by the representatives, each has copy to be retained by each institution. The English version of the agreement is officially considered by both parties.
