



AGREEMENT ON ACADEMIC COOPERATION

between

and

University of Sarajevo, Faculty of Pharmacy and Isparta University of Applied Sciences,

Faculty of Forestry establish the following agreement with the objective of scholarly cooperation, mutual understanding and the promotion of friendly relationships between two parties

Both parties undertake to promote and develop cooperation in the following ways on the basis of broad equality and reciprocity:

- 1. Exchange of academic information, materials and publications
- 2. Exchange and visits of academic staff
- 3. Exchange of Students and Study programs
- 4. Training and Visiting of Faculty Members and Staffs
- 5. Cooperation in research and the presentation of its results
- 6. Other academic exchange to which both parties agree

In order to give effect to these forms of cooperation, representatives of both parties will be encouraged to consult with each other and to develop specific plans for collaboration in any or all of the ways mentioned in Article 2:

1. Exchange of academic information, materials and publications

Both parties will explore the development of academic exchange programs. This will include exchange of university publications, treatises and research materials.

2. Exchange and visits of academic staff

Both parties will explore exchanges of faculty members for the purposes of research, reaching and other scholarly activities.

3. Exchange of Students and Study programs

Both parties will explore the exchange of students for long or short study programs. Each university will decide whether to grant transfer credit for courses taken at the other university.

4. Training and Visiting of Faculty Members and Staffs

* Both parties will explore faculty and administrative staff exchanges for the purposes of development and training.

The persons participating in the exchange under the terms of this agreement shall be nominated by the sending party and approved by the receiving party.

IV

Effectiveness

- i. This agreement will become effective on the date of signing.
- This agreement is effective for five years from the date of its signing. Amendments and ii. additions can be made to this agreement. These changes will be subject to agreement by both parties. .
- Financial obligations for programs and exchange will be discussed and agreed upon by both iii. parties in each case and outlined in contract agreements.
- iv. This agreement may be terminated by mutual consent. If termination occurs, the programs or exchanges in progress will continue until completed.
