## AGREEMENT ON ACADEMIC COOPERATION

#### Between the

# UNIVERSITY OF AVIGNON, FRANCE

#### And the

## UNIVERSITY OF SARAJEVO, BOSNIA-HERZEGOVINA

In recognition of the importance of exchanges in the domains of teaching and research, as well as the special opportunities provided by strengthening contacts between faculty members and students at the two institutions, **University of Avignon** and the **University of Sarajevo** are signing the following agreement in the field of academic cooperation.

## Article 1.

The purpose of this agreement is to establish a framework within which cooperation may develop regarding research, education, exchange of ideas, people, documents and material between the **University of Avignon** and the **University of Sarajevo**, in the academic fields of heritage and culture, especially within museology and chemistry applied to restoration, without excluding cooperation in other scientific areas epresented at both Universities.

#### Article 2.

The cooperation between the two respective institutions should specifically promote the following activities:

- Mutual exchange and collaboration of professors, researchers, students and other staff at both the undergraduate and post-graduate levels;
- Organization of summer universities, seminars and other forms of exchange of knowledge by both parties;
- Exchange of literature, textbooks and university publications:
- Realization of mutual projects;
- Exchange of experiences and mutual programs in the field of information systems, communications, and in the study of cultural patrimony materials;
- Exchange of administrative staff with the goal of gaining the necessary experiences and changes.
- Cooperation in the field of the university reform in accordance to Bologna Declaration and Lisboan Declaration
- And other forms of cooperation aimed to be mutually beneficial for both participants.

#### Article 3.

Both Universities will at least once a year agree upon the concrete forms and fields of cooperation. These collaborative programs can be changed or amendment by written agreement signed by both parties.

#### Article 4.

Collaborative activities will be reviewed every year.

## Article 5.

The scientific responsability for the realisation of this agreement in the areas quoted in Art. 1 is under the direction of :

for the University of Sarajevo.

M. Jean Davallon, professor at the Information and Communication department, director of the Doctorate School Human and Social Sciences, and of Mrs. Catherine Vieillescazes, professor at the Chemistry department, responsible for the research lab Chemistry applied to archeology.

Both parties shall designate a liaison office for this agreement of academic cooperation and for any subordinate agreements. For the University of Sarajevo, the office shall be the

For UAPV the liaison office shall be the 'Service des Relations Internationales' under the responsability of the Vice-President (International).

#### Article 6.

The present agreement will be signed as an ongoing agreement with no set time frame.

## Article 7.

The agreement shell enter into force on the date of the signature by both parties.

## Article 8.

Each University has the right to terminate the present document in writing within a six-month advance notice.

## Article 9.

This agreement will be presented in four identical copies (two in each language). Each University will receive two copies (one copy in each language).
