AGREEMENT OF COOPERATION BETWEEN

THE UNIVERSITY OF BOLOGNA FACOLTÀ DI SCIENZE POLITICHE
THE SCHOOL OF POLITICAL SCIENCE - FORLI CAMPUS

SEDE DI FORLÌ

AND THE UNIVERSITY OF SARAJEVO

The School of Political Science - Forlì Campus, of the University of Bologna, represented by its Dean, Prof. Guido Gambetta, and the University of Sarajevo, represented by its Rector Prof. Boris Tihi, agree to the following:

ARTICLE 1

This agreement is made by School of Political Science - Forli Campus of the University of Bologna, and the University of Sarajevo in order to promote cooperation in research and teaching and to encourage scientific, artistic and cultural projects of interest to both parties.

ARTICLE 2

Co-operation between the two Institutions may include:

- a) the realization of research projects of mutual interest upon a protocol to be defined, on a triennial basis;
- b) exchange visits of faculty members and researchers to carry out research and consultations and to encourage the training of scientific personnel:
- c) the organization of joint seminars, symposia and discussions on topics of common interest.
- d) the exchange of students.

ARTICLE 3

The School of Political Science - Forli Campus, of the University of Bologna and the University of Sarajevo agree that each Institution will plan to provide their own faculty and researchers with travel funds while the Host Institution will cover the cost of accommodation.

The faculty members and the researchers participating in said exchange, during their period at the hosting Institution to carry out the above-mentioned activities, will be considered as staff "on a mission" abroad.

ARTICLE 4

The hosting Institution will provide visiting staff, by opening of a policy, with appropriate medical and accident insurance, which will not cover chronic diseases and the need of prosthesis.

ARTICLE 5

Each Institution will appoint a co-ordinator for the exchange program.

ARTICLE 6

The resolution of possible controversies on the interpretation and the performance of such agreement will be devolved to an arbitration board made by a member of each Institution and a third member chosen by mutual consent.

ARTICLE 7

The present agreement is valid for a period of one year, it is tacitly renewed year by year, meanwhile each party will be able to express its intentions to withdraw by giving a 6 months written notice to that effect before its expiration.
