

**AGREEMENT OF COOPERATION BETWEEN
THE UNIVERSITY OF BOLOGNA –Polo Scientifico-Didattico di Forlì AND
THE UNIVERSITY OF SARAJEVO
FOR STUDENT MOBILITY FOR THE MASTER DEGREE IN INTERDISCIPLINARY RESEARCH IN
EAST EUROPEAN STUDIES (MIRESS)**

The University of Bologna, Polo Scientifico-Didattico di Forlì, represented by its president, Professor Guido Gambetta, and the University of Sarajevo, represented by its Rector, Professor Boris Tihi, agree to the following:

ARTICLE 1

The two Universities enter into this agreement in order to promote the mobility of the students and lecturers of the Master Degree in Interdisciplinary Research in East European Studies (MIRESS).

ARTICLE 2

The two Universities will promote the mobility of students each academic year from Autumn 2005. Students will be granted the exemption of the tuition and fees required by the hosting Universities. Any other cost, health care insurance included, will be paid by the applicants themselves.

ARTICLE 3

The minimum length of the study abroad period is one academic term of five months. This period may be extended, if all parts agree, for five more months. The maximum period of the study abroad period is therefore ten months.

ARTICLE 4

Participating students will continue as candidates for degrees at their home University and shall not be candidates for degrees of the host University. Participating students, by the time and till the end of enrolment abroad, cannot get their final degree at their home University.

ARTICLE 5

The three exams passed at the host University, including an exam in language, shall be validated by the home University according to the annex 1 of this agreement.

ARTICLE 6

A mutual teaching staff mobility among the University of Bologna and the other institution signing the present agreement is possible, with the sending institution covering the travel costs and the receiving institution providing for all the other costs as hosting institutions. If a specific request is made by the University of Bologna to a member of the teaching staff of the other institution signing this agreement to participate in the teaching activities of the MA MIRESS, the University of Bologna will cover all costs of the mobility.

ARTICLE 7

Each University will appoint a co-ordinator for the program.

ARTICLE 8

The resolution of possible controversies on the interpretation and the performance of such agreement will be devolved to an arbitration board made by a member of each University and a third member chosen by mutual consent.

ARTICLE 9

The present agreement is valid for a period of three years. Each of the two parties will be able to withdraw by giving a 6 months written notice to that effect.

ARTICLE 10

Every part of this agreement, including the addendum for the grading scale, constitutes an integral part of the agreement.
