



**AGREEMENT
FOR EDUCATIONAL AND SCIENTIFIC EXCHANGE**

between

UNIVERSITY OF SARAJEVO

and

**UNIVERSITA' DEGLI STUDI DELLA TUSCIA IN VITERBO
REPUBLIC OF ITALY**

The *Università degli Studi della Tuscia*, based in via S. Maria in Gradi 4, 00100 Viterbo, Italia, represented by its Rector, Prof. Alessandro Ruggieri, and the *University of Sarajevo*, based in Obala Kulina bana 7/II, 71000 Sarajevo, Bosnia & Herzegovina, represented by its Rector, Prof. Dr. Muharem Avdispahić, Dr.h.c., agree to establish academic cooperation for the purpose promoting educational and scientific exchange.

I

Cooperation between the two universities will be developed in the following fields:

- Agricultural Science
- Forestry Science

For the attainment of these purposes, the two Universities, by means of their units involved, will have to elaborate some specific projects that will be formally bound to the main agreement by following annexes.

II

As to the successful realisation of the Agreement, both universities agree to the following terms of exchange subject to the availability of appropriate resources and the agreement of collaborating academic department:

- ◆ Exchange of visiting academic, technical and administrative staff;
- ◆ Exchange of undergraduate and graduate student;
- ◆ Organisation of joint scientific conferences and workshops;
- ◆ Exchange of publications, university editions, books and co-operation in communication networks;
- ◆ Joint design and implementation of research projects.

III

The Host University will provide facilities for studying and research at no charge for designated staff.

In principle, the sending University will pay for the travel expenses and the host University will cover subsistence expenses. Each visit will be agreed well in advance between the two Institutions

and it will take place only after the formal agreement between the Authorities of both proper offices.

The University of Tuscia will contribute to the expenses for the mobility of teaching, technical and administrative staff and the mobility of students, in compliance with the Rules for accessing International Relations funds in force. Once the financial resources ascribed to the International Relations to this aim will not be available, the exchange can take place all the same on a personal payment base.

IV

The two universities will make joint applications to the EU institutions and organisations for research grants and funds available in the mutually defined fields and topics where collaborative links are established.

V

Any article of this Agreement may be amended or revoked after consultation and mutual consent between the two universities.

VI

This Agreement is concluded for an initial duration of five years from the date of joint signing. After this period this Agreement can be re-examined if deemed necessary. After five years, the Agreement shall be renewed for another five-year period, unless terminated by one of the parties by written notice three months prior to the expiration date.

VII

This Agreement is signed in two identical copies in English language.

Following the spirit of academic co-operation and principles of mutual understanding and respect, we sign this Agreement.
