**The Iustinianus Primus Faculty of Law** at the Ss. Cyril and Methodius University in Skopje (Republic of Macedonia), represented by the Dean, Prof. Borče Davitkovski, Ph.D., on one side,

and

**The Faculty of Political Sciences** at the University of Sarajevo (Republic of Bosnia and Herzegovina), represented by the Dean, Prof. dr. sc. Šaćir Filandra, on the other side, conclude the following

## **AGREEMENT FOR ACADEMIC COOPERATION**

### **Article 1**

The purpose of this Agreement of Academic Cooperation (hereinafter: "Agreement") is development of academic cooperation at the political science under-graduate and post-graduate level, development of scientific, research and cultural activities between the two faculties involving their students as well as the academic staff.

The Agreement is concluded on the basis of positive experiences and cooperation obtained at the faculty level. It has the aim to reinforce and develop multilateral scientific, research and pedagogical contacts.

The cooperation will proceed on the basis of democratic principles in compliance with the legislative and institutional autonomy of both parties.

The Iustinianus Primus Faculty of Law at the Ss. Cyril and Methodius University in Skopje (Republic of Macedonia) and the Faculty of Political Sciences at the University of Sarajevo (Republic of Bosnia and Herzegovina) (hereinafter: "parties to the agreement") bind themselves to take into consideration the common needs during their cooperation in order to benefit from the scientific, educational and cultural exchange and development.

## **Article 2**

The cooperation between the parties to this Agreement will proceed in the following areas:

- a) common scientific and research activities at the graduate, post-graduate and doctoral level;
- b) joint activities related to the presentation and dissemination of the results from the scientific and pedagogical research of the two parties at home and abroad.

The statutory representatives of the two parties of this Agreement agree to appoint persons responsible to coordinate and control the implementation of the present Agreement and will notify each other on their identity in written.

## **Article 3**

The parties of this Agreement will make utmost efforts to apply for and realize joint scientific projects with a particular emphasis on the governmental cooperation programs concluded between the Republic of Macedonia and the Republic of Bosnia and Herzegovina.

## **Article 4**

The parties to this agreement will support contacts in the field of education, as well as student exchanges at the undergraduate, post-graduate, and doctoral (Ph.D.) level. The conditions concerning the student exchanges will be stipulated in an additional agreement.

## **Article 5**

The parties in this Agreement will support the exchange of scientific and pedagogical materials and information regarding the areas that constitute the purpose of this Agreement (information on newly published scientific and education literature, recent proceedings and journal issues, etc.).

## **Article 6**

The parties at this Agreement will exchange members of their academic staff and students on annual basis, in proportion of up to 2 (two) persons, based on reciprocity.

The distribution of costs will be determined upon prior agreement before each exchange. In case of a failure to comply with such an agreement, each party shall cover its own costs.

## **Article 7**

The Agreement is concluded with an unlimited duration. It enters into force on the day of its signing by the statutory representatives on behalf of both institutions, subject to a prior approval of the authorized organ of the

respective Faculty, depending on which approval will occur later, and subject to notification of persons referred to in paragraph 2, Article 2 of this Agreement.

The changes and amendments related to this Agreement can be made in a written form based on prior agreement of both parties following a proposition from each party.

### Article 8

This agreement is concluded in English Language.

### Article 9

Both parties bind themselves to confirm the conditions of the Agreement. In this spirit, the Deans of the two institutions sign the document.

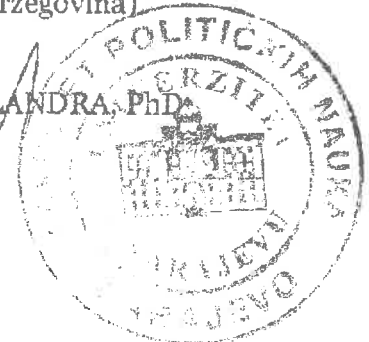
