

AGREEMENT ON ACADEMIC EXCHANGE  
between  
MALMÖ UNIVERSITY, FACULTY OF ODONTOLOGY, SWEDEN  
and  
UNIVERSITY OF SARAJEVO, SCHOOL OF DENTISTRY,  
BOSNIA AND HERZEGOVINA

In recognition of the mutual benefits derived from scholarly interaction, the Faculty of Odontology, Malmö University and the school of Dentistry, University of Sarajevo, join in the following agreement on cultural, educational, and scientific cooperation. The two institutions agree to cooperate in the following academic activities:

A. Scope:

1. Exchange of faculty members for teaching and/or research - numbers, fields and duration to be determined by mutual consent.
2. Joint research projects - title, chief investigator, scope, duration, budget and publications of results, etc. to be determined by mutual consent.
3. Exchange of undergraduate and postgraduate students - numbers, type and duration to be determined by mutual consent.
4. Exchange of publication and research materials related to dental education and research.

B. Conditions:

1. Faculty members of the School of Dentistry in Sarajevo wishing to go to Malmö University for teaching and/or research, after approval by the Faculty of Odontology, Malmö University, shall be given proper assistance by Malmö University. Faculty members of Malmö University going to the School of Dentistry in Sarajevo, after approval by the School of Dentistry in Sarajevo, shall be given proper assistance by the School of Dentistry in Sarajevo.
2. Expenses of a joint study should be borne, in principle, by the originating party. The results of the joint study may be published jointly and separately according to mutual consent. If it is published separately, it should show the organization which carried out the research.
3. Undergraduate or postgraduate students of the School of Dentistry in Sarajevo wishing to go to the Faculty of Odontology, Malmö University for training and/or research, after approval by the Faculty of Odontology, Malmö University, shall be given proper assistance by Malmö University.


Students of Malmö University going to the School of Dentistry in Sarajevo, after approval by the School of Dentistry in Sarajevo, should be given proper assistance by the School of Dentistry in Sarajevo.


4. The host institution shall secure and maintain appropriate professional liability insurance or properly reserved self-insurance for the students who participate in clinical practice as part of the curricula. Upon request by the home institution, the host institution shall provide evidence of this insurance coverage.
5. In the absence of any specific agreement to the contrary, all expenses of salary, travel and living and allied costs will be the responsibility of the visitor's home faculty or the visitor.
6. Each party will bear its own mailing cost in exchange of research materials and publications.
7. The host institution will assist, as far as possible, in arranging accommodation for the visitor, and will assist in matters of health, language and local customs.
8. Both parties shall abide by the principle of equal opportunity and shall not discriminate on the basis of race, sex, age, ethnicity, religion or national origin in the administration of the Agreement relating to the exchange of students and scholars.
9. One contact person for each faculty will be elected to handle all contacts and to be responsible for practical arrangements and continuity.

C. Duration:

This agreement shall take effect from the date of signature and the agreement shall be subject to modification or cancellation at any time by either institution with six months notice.


