

Co-operation Agreement between the University of Sarajevo, the Republic of Bosnia and Herzegovina and the University of Trnava, the Slovak Republic

Preamble

In order to facilitate international academic exchange and to strengthen the academic and scientific cooperation, the University of Sarajevo, Bosnia and Herzegovina and the University of Trnava, the Slovak Republic agree to establish mutual formal relations which shall serve as the framework for further development and promotion of the cooperation by teacher and student exchanges; teaching and research; grants; exchange of publications; curriculum development; participation on conferences and workshops; conducting accreditation site visits and development of international efforts and projects. The co-operation is based fully on the sincerity and willingness of both sides to further promotion all of co-operative possibilities and it is hoped to bring benefits, establishing a solid partnership between both parties to the co-operation agreement.

The parties to the Agreement agree as follows:

Article I

Both universities plan short-term exchange visits of educators, professionals and scientists. The exchange visit at any partner university is focused on lecturing and research. Lecture topics are expected to be agreed in written form, at least two months in advance.

Article II

Both universities will encourage and support student exchanges. This covers exchange relations in academic studies as well as cultural and other fields.

Article III

Both partners will support mutual participation at professional conferences, symposiums, workshops, colloquia organized by the either of both universities.

Article IV

Unless otherwise agreed upon in the special executive agreement, no tuition expenses will be claimed by the hosting university.

Article V

The insurance expenses during the stay will be covered by participants in the exchange programme.

Article VI

Both universities will encourage and support joint activities/projects in developing countries and third-world countries.

Article VII

Travel expenses for the academic and research staff will be carried by the sending university and accommodation by the hosting university.

Article VIII

This co-operation agreement is concluded for the period of five years its signature period (2012-2016) by representatives of both universities. Detailed plans and activities for each year will be made by respective faculties of both universities on the basis of mutual contacts, needs, suggestions and possibilities.

Article IX

Any changes and/or additions to this co-operation agreement shall be made in writing and approved by both parties. A notice to change the co-operation agreement may be written by December 31st of each year; otherwise, this co-operation agreement is renewed automatically for the upcoming year.

Article X

Original of this co-operation agreement is written in English and it comes into force on the day it was signed by representatives of both universities.
