# FROM THE PRESIDENT

The CPWP has undergone its healthy and constructive development in the past year. In view of its goal and mission, the CPWP has continued its substantial efforts in providing its members with opportunities and platforms to facilitate academic exchange and engaging discussion in comparative philosophy as a general way of doing philosophy through cross-tradition engagement toward world philosophy.

In this connection, in 2023, the CPWP organized/cocoordinated two academic events. First, the Society coordinated two group panel sessions at the 2023 APA Pacific Division meeting (San Francisco, California, USA, 5-8 April 2023). [See its separate report below.] Then, in the 2023 summer, the Society together with the Comparative Philosophy Forum - Beijing study group, ISCWP (the International Society for Comparative Studies of Chinese and Western Philosophy) and the journal Comparative Philosophy co-sponsored the workshop on the theme "Comparative Studies of Chinese Philosophy toward World Philosophy" (Beijing, China / 1-2 August 2023); although this workshop focuses on the case of Chinese philosophy as part of world philosophy, it also has its general methodological significance on comparative studies of other philosophical traditions toward world philosophy.) At the upcoming 25<sup>th</sup> World Congress of Philosophy

(Rome, Italy / 1-8 August 2024), the Society will cocoordinate a roundtable on the theme "Approaching Philosophy Across Boundaries: Constructive Engagement and Normative Bases". This roundtable examines some foundational theoretic and methodological issues involved in one representative strategic approach (sometimes labeled "constructiveengagement" approach) to philosophy across boundaries, which has been theoretically explored and carried out in the reflective practice (especially since the start of this century); among others, the discussion is on the issue of normative bases for cross-tradition engagement in philosophy in some closely related connections.

To have these critical discussion opportunities available to all the interested members, the Society has made serious efforts in employing the available virtual means (especially via OWL device through internet), which would allow the interested members who are unable to physically attend the events on scene to effectively participate in the events in a virtual way. This especially meaningful and significant to an is international academic association like the CPWP whose membership is located globally, rather than locally (limited to one country or one area) and the availability financial resources of whose membership is unbalanced sensitive to distinct locations. The Society will continue making efforts in providing its interested members with remote availability of its organized or co-coordinated academic events (when internet connection available).

For your info, this Newsletter also includes the content pages of the two most recent issues [Vol 14 No 2 (July 2023 Issue) and Vol 15 No 1 (January 2024 Issue)] of the journal *Comparative Philosophy*, for which the CPWP is one of co-publishers.

In this coming May, according to the CPWP Constitution, we will hold the election for the new Vice President and the new Secretary-Treasurer of the coming 2024-2027 term of the Executive Board; Prof. Nevad Kahteran, the current Vice President is to succeed me as the President of the next Board.

(2024) A paper entitled, "Mengzi's Dialogue with Gaozi and Gongduzi" was presented at the Eastern Meeting of this the APA on 1/16/24. The abstract is Mengzi 6A can be seen as a play consisting of five acts signaled by changes of speaker. I describe this dramatic context, and use it to shed light on the philosophy within 6A. In the first act, Mengzi and Gaozi are engaged in a *debate* (in which the goal is winning) rather than a dialogue (in which the goal is understanding). The apparent goal is intellectual progress, but the actual goal is to win the approval of the onlookers. Attending to this dramatic context reveals that Gaozi is not defending a single position. Instead, he moves from concession to

concession under the repeated rebuttals of Mengzi. The middle three acts portray the debate of Gongduzi and Ming Jizi in order to invite the readers to do philosophy, themselves. Only in the last act of the dialogue does Mengzi speak both clearly and philosophically. He responds to Gongduzi's sincere questions by saying that some people end up with vices despite possessing a good human nature because they lack goods of fortune, and others end up with vices because they make bad value choices caused by virtue's bad reputation."

"My primary work done in 2023 was to prepare my retirement speech scheduled on January 10th, 2024, under the title "A Retrospect to the Early History of Comparative Philosophy China and the West: Seeking the Core of the Wisdom of Chinese Philosophy," which shows my entire research work in comparative philosophy is to affirm the rational function of philosophy as wisdom and as the inner core of Chinese and Western cultures. By comparing Chinese and Western philosophy with their common elements, such as natural theology, organic metaphysics, and spiritual rationality, my retirement speech addresses the issues of how the encounter of Chinese and Western philosophy began ever since Matteo Ricci (1583) came to China in the late

Sixteenth Century, the negative role played by Eurocentrism in the assessments of Chinese philosophy made by Western philosophers such as Malebranche, Kant, and Hegel, how the position of non-Eurocentrism held by Leibniz, Wolff, and Whitehead have benefit the communications between Chinese and Western philosophy, and how we acquire the understanding of the core of the wisdom of Chinese philosophy, namely, the primordial humanism and natural Daology, as the distinguished features of Chinese philosophy through this historical retrospect. My approach is to follow Thome Fang (方東美) and Shih-chuan Chen (程石泉) in their commitments to restoring the original Confucianism and Daoism, seeking the spiritual counterparts of Chinese philosophy from Greek philosophy and Whitehead, incorporating the philosophy of Yijing with Huayan Buddhism and contemporary process philosophy, and to promote the philosophical thoughts of comprehensive harmony."

## ABSTRACT

This roundtable examines some foundational theoretic and methodological issues involved in one representative strategic approach (sometimes labeled "constructive-engagement" approach) to "philosophy across boundaries", which has been theoretically explored and carried out in the reflective practice (especially since the start of this century); among others, the discussion is on the issue of normative bases for cross-tradition engagement in philosophy in two related connections: <1> how it is possible for different philosophical traditions with distinct ultimate realities to have common normative bases for talking about the same things differently and having jointly concerned issues with distinct approaches and thus constructively engaging with (instead of passing by) and learn from (instead of dismissing) each other to make joint contributions to the development of philosophy; <2> how it is possible for plural methodologies in cross-tradition engagement to have unifying normative bases.




